  - (c) to sign on my behalf any documents pertaining to the purchase and/or sale of the Property, including, but not limited to, the entering into of the agreement of purchase and sale for the Property, any amendment or amendments thereto, or any reinstatements or assignments thereof, and any and all documentation relating to the interim occupancy or final closing relating to the Property including any transfer or HST rebate application, if applicable; and
  - (d) to direct the solicitor acting on my behalf in the purchase of the Property to pay all deposits, occupancy and closing proceeds payable to the Vendor or its solicitors, as they so direct.

#### **TEST TO GIVE POWER OF ATTORNEY**

- 4. IN MAKING this general power of attorney for property, I am aware of the following:
  - the nature of my property and its approximate values;
  - the obligations I owe to my dependants;
  - My Attorney will be able to do on my behalf anything in respect of property that I could do, if capable, except make a Will, subject to any conditions or restrictions contained in this document;
  - My Attorney must account for his or her dealings with my property;
  - I may, while capable, revoke this continuing power of attorney for property;
  - the value of my property may decline, whether through the imprudent management of it by My Attorney or otherwise; and
  - there is a possibility that My Attorney could misuse the authority given by this continuing power of attorney for property.

#### SPECIAL INSTRUCTIONS

5. **I DIRECT** that My Attorney register the herein General Power of Attorney for Property forthwith with the appropriate Land Registry Office that deals with the Property.

- 6. UNLESS otherwise stated in this document, this general power of attorney for property:
  - (a) comes into effect on the date it is signed and witnessed as set out below; and
  - (b) expires upon the registration of a revocation of the herein General Power of Attorney with the Land Registry Office that deals with the Property pursuant to s.70(3) of the *Land Titles Act*, R.S.O. 1990, c. L.5, or as amended.
